The selection of the best bid will be made by applying the criterion of the most economically advantageous offer, which means the highest offered Net present value of the total contract costs

Price expressed through the Net present value of the total contract costs in dinars or euros, calculated in accordance with the instructions in Chapter VI, Item 10 of the Tender Documents;

Bid submission method and bid submission deadline:

Interested bidders shall submit their bids, either directly or by mail, in a sealed envelope or box, closed in such a way that it can be determined with certainty that it is opened for the first time during the bid opening session.

Provide the name and address of the Bidder on the back of the envelope or on the box.

If the bid is submitted by a group of bidders, the envelope or box must indicate that this is a group of bidders and indicate the names and address of all participants in the joint bid.

Present representatives of tenderers must submit authorization for participation in the tendering procedure to the Commission before the public opening of tenders.

Time limit for reaching a decision: The decision to award the contract will be taken no later than 25 days after the date of the opening of tenders.
